<b>Symptoms of Exposure:</b> Direct contact with the uncured material may irritate the eyes and skin. Vapors may irritate the eyes, skin, and respiratory tract particularly in an enclosed or poorly ventilated area. Overexposure to toluene may cause fatigue, confusion, headache, dizziness, drowsiness, dilated pupils, secretion of tears, anxiety, or insomnia. Peculiar skin sensations (e. g. pins and needles) or numbness may also be produced. Very high concentrations may cause unconsciousness and death. Harmful or fatal if swallowed. Aspiration can cause chemical pneumonitis, which may be fatal. Repeated or prolonged contact has a defatting action, causing drying, redness, dermatitis. Liver and kidney damage may occur. Exposure to toluene may affect the developing fetus.	
<b>Medical Conditions Aggravated By Exposure:</b> Persons with pre-existing skin disorders or impaired liver or kidney function may be more susceptible to the effects of this substance. Alcoholic beverage consumption can enhance the toxic effects.	
<b>Primary Route (s) of Entry:</b> Inhalation and skin or eye contact.	
<b>Emergency First Aid:</b> Inhalation: move to fresh air. If breathing is difficult, give oxygen. Call a physician. Skin: remove material and wash with soap and water. Eyes: flush with running water for 15 minutes. Consult a physician. Ingestion: consult a physician immediately.
